## Declaration

- 1. I hereby declare that I have not appeared for any Fact Crescendo interview in the past 3 months. If at any point of time it is found otherwise, the offer can be revoked.
- 2. No request to change the Date of joining will be entertained. However in special cases only an authorized Fact Crescendo PERSONNEL / HR can do so.
- 3. I understand that the joining formalities / documentation need to be completed on or before the day of joining. And the company has the right to WITHHOLD my salary till that is completed.
- 4. I have clearly understood the compensation structure offered to me and I agree to the same.
- 5. I have been briefed about the Training procedure and the related certification process associated with it.
- 6. I understand that there would be a Preliminary Gateway Assessment conducted on the Date of Joining. If I do not clear the Preliminary Gateway assessment, I will have to undergo bridge training and would be re-assessed post bridge training.

- 10. I will not accept any present, commission or any sort of gratification in cash or kind from any person, party or firm or Company having dealing with the company and if I am offered any, I would immediately report the same to the Management.

The Company also reserves the right to terminate your services without any notice or salary in lieu thereof on the grounds of misconduct, or even in the case of reasonable suspicion of misconduct, disloyalty, commission of any act involving moral turpitude, or any act of indiscipline or inefficiency or for loss of confidence.
- 18. This appointment is also subject to a satisfactory report from your former employers, based on the references given by you.
- 19. You will automatically retire from the service of the Company on attaining the superannuating age of 58 years. You will be expected to provide acceptable evidence of your date of birth at the time of joining the company.
